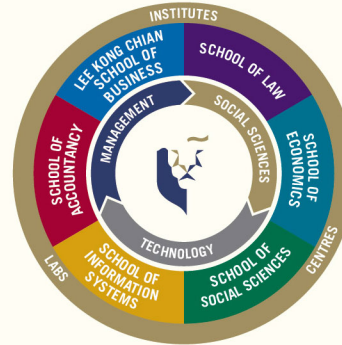

INFORMATION FOR APPLICANTS

ENTRY REQUIREMENTS

We welcome university students from around the world who have:

- ✓ completed a year of undergraduate studies
- ✓ a cumulative grade point average of 3.0 out of 4.0, or equivalent

Students are advised to check with their home university on transfer of course credits before applying.

LANGUAGE PREREQUISITES

Students for whom English is not their first language or who are not from English-medium institutions should fulfil one of the following requirements:

- ✓ IELTS score of 6.5
- ✓ TOEFL score of 550 points (paper-based) or 79 points (internet-based)
- ✓ Any other English Language qualifications as determined by SMU
